





HOMEPAGE - DATA PROTECTION DECLARATION

The protection of your personal data is very important to us. Therefor we process your data exclusively on the basis of the legal regulations (GPDR, DSG, TKG 2003). Below we would like to inform you for what purposes your data are collected and used and how you can execute your rights.

Use of personal data and data storage

Controller within the meaning of the EU-GPDR is the Kontext Druckerei GmbH, Spaunstrasse 3a, 4020 Linz - hereafter named KONTEXT

For the purpose of easier customer service and possible future contract processing, the following personal data will be collected and processed:

- name / company
- address
- phone number
- e-mail address
- additional information (depending on the desired service)

KONTEXT processes your personal data for the fulfillment of the contract or for the execution of pre-contractual measures, as well as for information and marketing purposes. Without this data, we cannot conclude or fulfill the contract with you.

For the purpose to contract execution, it is necessary to pass on your personal data to internal and external service providers (suppliers, processors, processing banks / payment service providers for the purpose to debiting the purchase price, to the transport company / shipping company commissioned by us to deliver the goods). These above mentioned third parties are appointed by KONTEXT within the meaning of Art. 28 GPDR as a processor and obliged to provide data security in accordance with Art. 24 and 32 GPDR.

Your data will only be processed within the EU.

We store your personal data exclusively within the scope of legal obligations.

Rights

Each customer who transfers personal data to KONTEXT has the right of information according to Art. 12/13 GPDR, information according to Art. 15 GPDR as well as correction or deletion of personal data and restriction of processing in accordance with GPDR.
